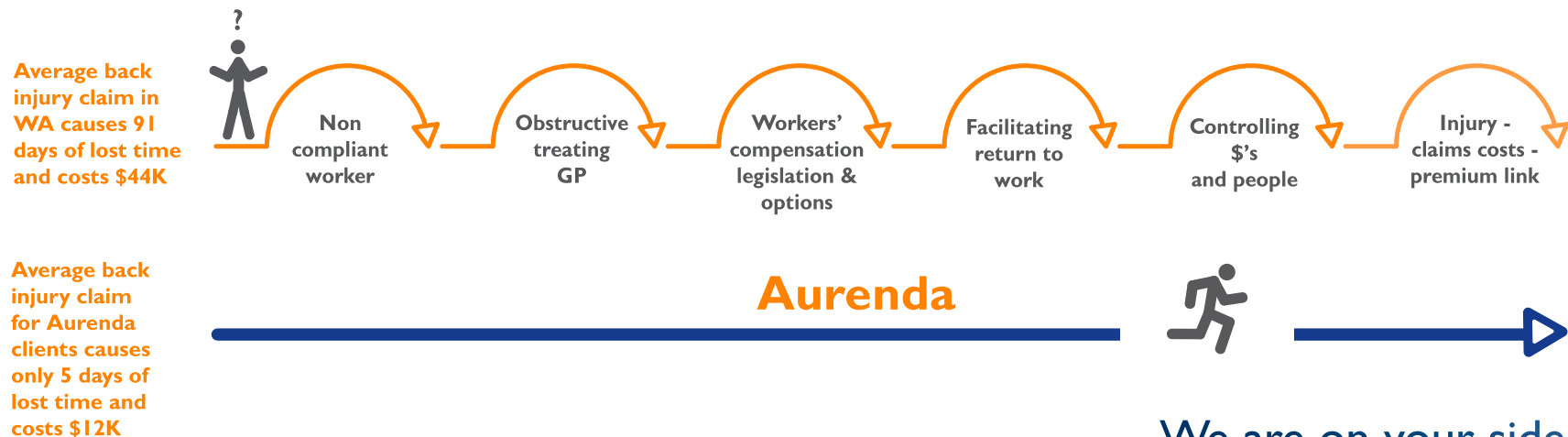

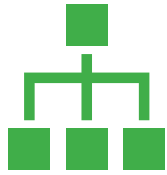

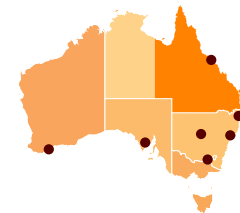

We work with clients across all states and territories, with a large client base in rural Western Australia, South Australia, Victoria, Queensland and New South Wales.

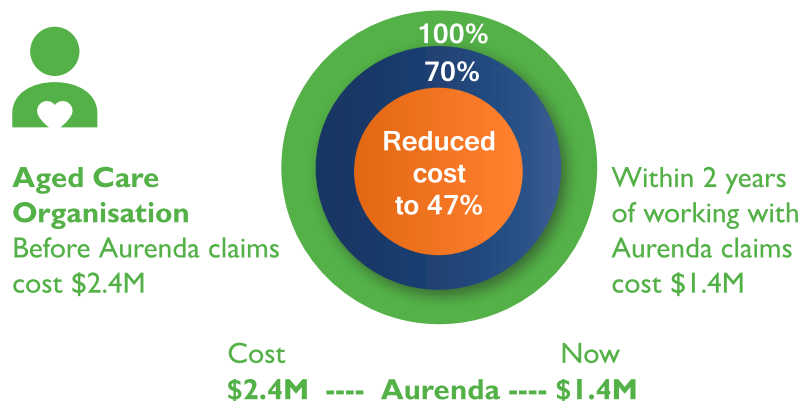
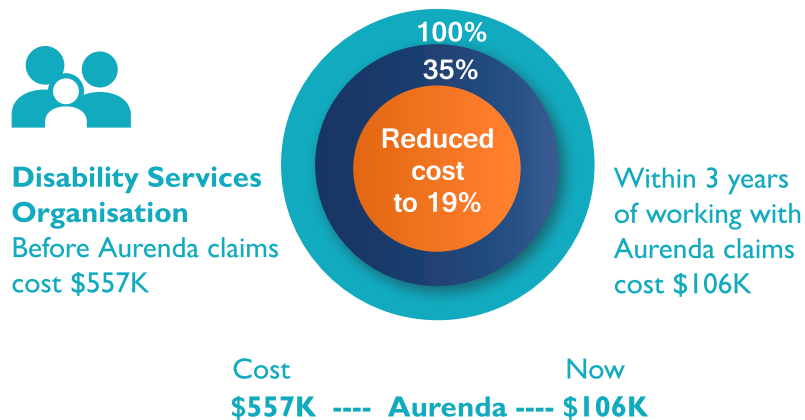

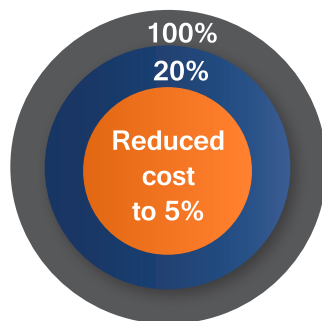

Before Aurenda claims cost \$2.3M



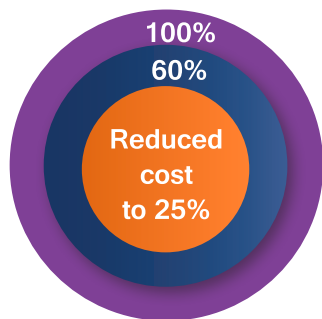
