We will audit your systems in accordance with the WorkSafe Plan Assessment with the objective of your business achieving a WorkSafe Silver, Gold or Platinum award.

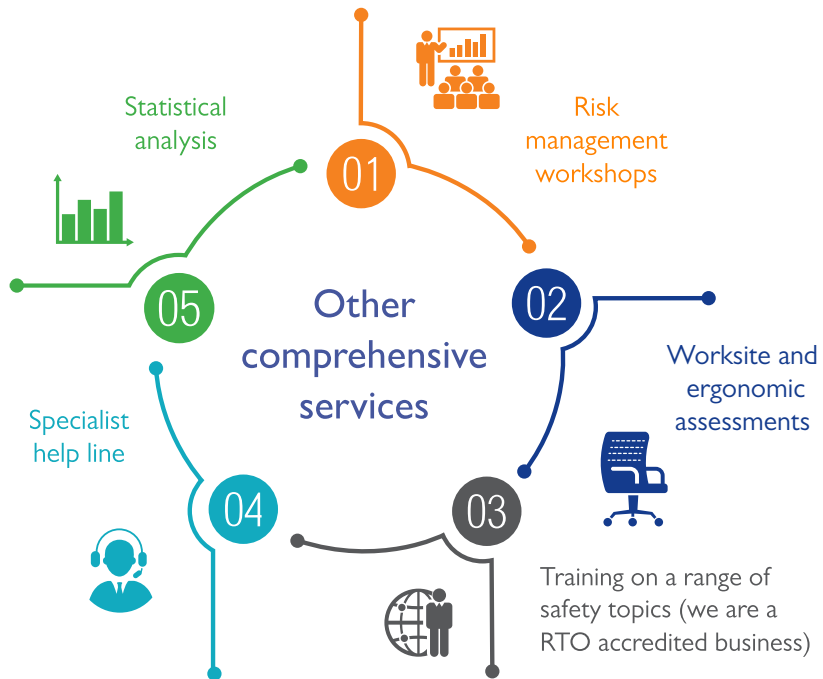
